BY-LAW NUMBER 026-2024

A By-law to amend the Fees and Charges By-law 224-2023, to correct fees for late renewals, Type 3 refreshment vehicles, failure to attend a meeting before a Screening Officer, mobile sign permits, and Animal Services related fees.

WHEREAS sections 8, 9 and 11 of the *Municipal Act, 2001*, S.O. 2001, c.25 (“Municipal Act”), authorize a municipality to pass By-laws necessary or desirable for municipal purposes, and in particular paragraph 3 of subsection 11(2) authorizes By-laws respecting the financial management of the municipality;

AND WHEREAS section 11(3) and provisions of Part IV of the *Municipal Act* provide that a municipality may pass By-laws respecting business licenses;

AND WHEREAS staff are updating fees to be correct, in line with annual budget increases;

NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:
