

Pre-Authorized Tax Payment Program



ONE OF THE MANY CONVENIENT WAYS TO PAY YOUR PROPERTY TAXES

The City of Vaughan offers two pre-authorized tax payment (PTP) plans:

PLAN ONE:

Property taxes paid in 10 instalments

Payments are deducted from the registered bank account on the first banking day of each month from March to December.

- **Interim property tax bill** (mailed in February): equals approximately half of the previous year's taxes, divided into five monthly payments from March to July
- **Final property tax bill** (mailed in June): accounts for the remaining property tax value, divided into five monthly payments from August to December

PLAN TWO:

Property taxes paid in six instalments

Payments are deducted from the registered bank account on each due date listed in the Interim and Final tax bills.

- **Interim property tax bill** (mailed in February): equals approximately half of the previous year's taxes, divided into three payments due in March, April and May
- **Final property tax bill** (mailed in June): accounts for the remaining property tax value, divided into three monthly payments due in July, August and September

Application deadline

You may sign up for this program at anytime as long as there is no outstanding balance on your account. Your completed application must be received at least 15 days before the withdrawal date you select to be enrolled. Once enrolled, you will receive written notification of your acceptance in the program. Continue to pay your taxes through your regular payment method until you receive your PTP enrolment confirmation letter.

Request for Pre-Authorized Tax Payment Program Payments

I/We acknowledge that any payment not cleared by the bank and returned to the City will result in a cancellation of the program. Any account which has been cancelled from this program shall revert to the regular instalment billing system and be subject to applicable fees and/or penalty and interest charges.	
I/We acknowledge that the City will charge a fee, plus an applicable penalty, for any payment not cleared through the bank.	

- I/We have attached a void cheque and have indicated below the Preferred Plan I/We wish to participate in.
- I/We have certain recourse rights if any debit does not comply with this agreement. For example, I/We have the right to receive reimbursement for any debit that is not authorized or is not consistent with this Pre-Authorized Tax Payment Program Agreement.

If you are already enrolled in any pre-authorized plan and are billed supplementary or omitted taxes, these amounts will be deducted from your bank account. Any fees or penalty incurred after enrolment must be paid separately to remain on the program.
