BY-LAW NUMBER 033-2017

A By-law of the Corporation of the City of Vaughan to amend Parking By-law No. 1-96, as amended, to remove a no-parking restriction on the east side of Islington to increase short-term visitor parking in the Kleinburg Village area, and to implement a parking prohibition on the south side of Woodbridge Avenue, between Clarence and Islington to improve traffic flow.

WHEREAS section 8(1) of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, provides that the powers of a municipality shall be interpreted broadly as to confer broad authority on a municipality to (a) enable it to govern its affairs as it considers appropriate, and (b) enhance its ability to respond to municipal issues;

AND WHEREAS section 11(3) of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, provides for lower-tier municipalities to pass by-laws respecting matters pertaining to highways, including parking and traffic on highways, and parking, except on highways;

AND WHEREAS the Council of The Corporation of the City of Vaughan wishes to continue to improve the municipality's road network by ensuring that parking regulations take into account safe and effective vehicular and pedestrian traffic flow, and the need to minimize obstructions for the provision of municipal services;

NOW THEREFORE the Council of The Corporation of the City of Vaughan ENACTS AS FOLLOWS:

1. Amend Parking By-law 1-96, as amended, as follows:

- (a) Amend Schedule "A" Part 1 by deleting the following entry:

<u>HIGHWAY</u>	<u>SIDE</u>	<u>FROM AND TO</u>	<u>PROHIBITIONS</u>
Islington Avenue	East	A point 65 metres south of the south limit of John Street to a point 135 metres south of the south limit of Bell Court	Anytime

(b) Amend Schedule "A" Part 1 by adding, in alphabetical sequence, the following entries:

HIGHWAY	SIDE	FROM AND TO	PROHIBITIONS
Islington Avenue	East	North limit at John Street to south limit at 65 metres south of John Street.	Anytime
Islington Avenue	East	North limit at 135 metres south of Treelawn Boulevard to south limit at 64 metres north of John Street.	Anytime
Woodbridge Avenue	South	East limit at 75 metres west of Islington Avenue and west limit at 35 metres east of Clarence Street.	Valid only Mondays through Fridays, from 7:00 a.m. to 9:00 a.m.

2. This By-law comes into effect and force on the date enacted by City Council.
