A By-law to amend City of Vaughan By-law 001-2021, as amended.

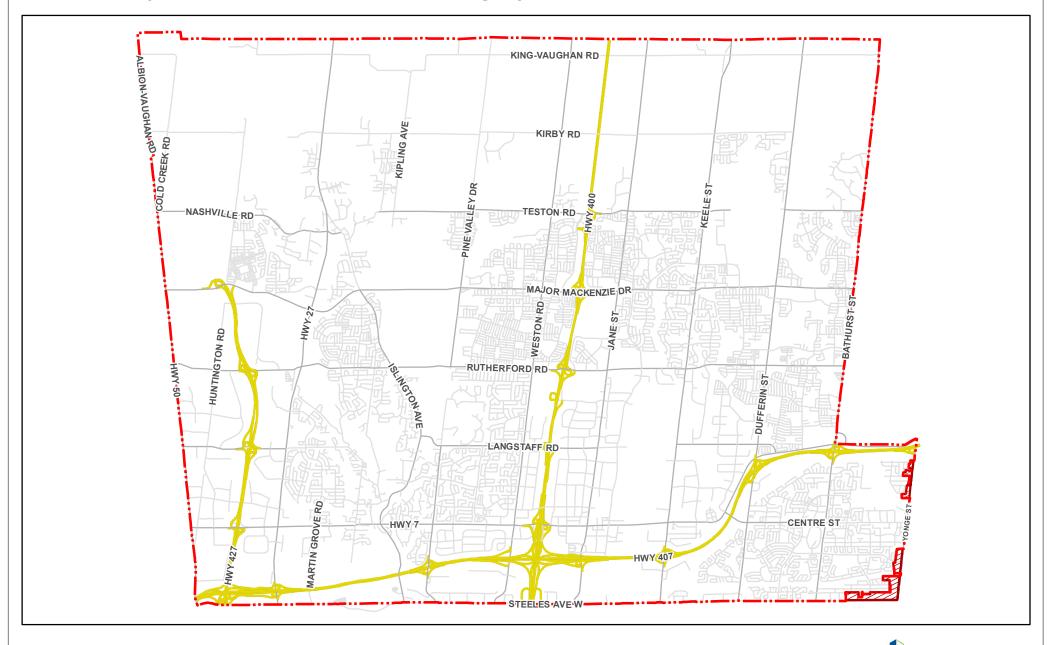

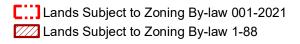
#### SUMMARY TO BY-LAW 025-2025

The lands subject to this By-law include all lands within the City of Vaughan, in the Regional Municipality of York, with the exception of lands in the vicinity of Yonge Street and Steeles Avenue, where By-law 001-2021 is applicable.

The purpose of this by-law is to amend City of Vaughan Zoning By-law 001-2021 to add the reference to Part 5 of By-law 001-2021 for <u>Public Parking</u> as the requirements of Section 5.16 Public Parking are applicable to the <u>use</u>. This By-law is an administrative correction to Zoning By-law 001-2021 and is deemed a "reference error" under Policy 10.1.4.7.b of Vaughan Official Plan, 2010.
